PURPOSE STATEMENT:

Reporting to the Projects Team Leader, the Plumber will be expected to carry out repair and maintenance of all plumbing and related installations in order to maximize usability in all facilities at Kenya Medical Supplies Authority in and around Nairobi and on occasion other KEMSA Depots across Kenya
