Authority Inches Closer to Meeting Full Customer Orders

In recent months, the Kenya Medical Supplies Authority (KEMSA) has made significant strides towards meeting the full spectrum of customer requests for essential medical supplies. This progress comes after months of meticulous planning and execution, with KEMSA's Order Fill Rate showing a steady increase, marking a departure from its previous stagnation below 45%.

The half-year report ending December 2023 revealed encouraging trends, indicating a steady growth in the availability of Essential Medicines and Program commodities. KEMSA has set an ambitious target of achieving a 90% Order Fill Rate, with a 10% allowance for stockouts at its worst performance. The Authority has also successfully addressed 80% of customer complaints, meeting the target, and resolved 77% of these concerns on time, slightly below the 90% target.

Dr. Andrew Mulwa, KEMSA's Chief Executive Officer, expressed confidence in the organization's ability to achieve impressive results by mid-year, citing the commitment from the board

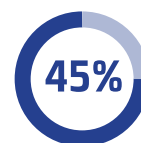
and staff. In the first half of the year, KEMSA serviced over 53,000 orders to more than 8,000 health facilities countrywide, achieving an on-time delivery rate of 70%. Despite falling slightly below its ideal target, the Authority's turnaround time averaged 14.8 days for hospital orders and 18.4 days for Primary Health Facilities (PHFs). Dr. Mulwa noted that maintaining optimal stock levels on all essential medical commodities is crucial to meeting customer requests and expanding the product range.

To maintain integrity throughout the supply chain, KEMSA has deployed the use of Electronic Proof of Delivery, recording a 62% use, shy from the target of 90%. Dr. Mulwa remains optimistic about KEMSA's ability to meet nearly all customer requests by procuring vital and tracers items required in health facilities.

As KEMSA continues to make strides towards improving its operations and meeting customer demands, the Authority is positioned to play a crucial role in ensuring the availability of essential medical supplies and improving healthcare delivery across Kenya.

New KEMSA Has Come A Long Way

Looking back over the last one year, as we forge ahead in our transformation journey, we have to acknowledge the milestones we have crossed, and review the lessons we have learnt along the way as we prepare for the challenges that lie ahead

Since the inauguration of a new board by Health Cabinet Secretary Susan Nakhumicha a year ago, there is no gainsaying that the Kenya Medical Supplies Authority (KEMSA) has undergone a major transformation.

In the process, the leadership team, including the top management, has created a fit-for-purpose organisation able to deliver quality, reliable and affordable Health Products and Technologies for Kenyans. But we also acknowledge that there is still much more that we need to do as an organisation to improve our processes and turn-around times, well aware that constant improvement is a journey, not a destination.

In this journey, we are guided by our true North, which is our Vision as an Au-

thority: to pursue excellence in the provision of Healthcare Products and Technologies (HPTs) and supply chain solutions in the East Africa Region. Soon after its inauguration, the new board engaged in a deep dive of key areas in the organisation; Procurement, Operational, Financial and Human Resource functions, and identified key concerns in each. To address these concerns, they formulated turnaround strategies aimed at transforming KEMSA into an effective strategic procurement agency for the entire health sector as envisioned in the Vision 2030 development blueprint. These strategies were in turn informed by our Mission, which is to provide quality, affordable, essential HPTs and supply chain solutions to save and transform lives. The Vision 2030 blueprint clearly stipulates that "since drugs and

other medical supplies are paramount in the delivery of quality health care, there is a need to strengthen KEMSA to be a strategic procurement agency for the entire health sector."

And to enhance the capacity and management of KEMSA, Vision 2030 recommended that the Authority should be able to service a pull system for all facilities in Kenya over the next five years. This is meant to avoid delays in the supply and delivery of essential drugs and medical technologies.

Before the new board and management team took over, KEMSA was bogged down by a myriad of challenges, including a toxic work environment that affected staff morale, delayed payments to suppliers and a bad reputation arising from past scandals. To strengthen the management of the Procurement department, the new board led by its Chair, Mr Irungu Nyakera, announced a raft of initiatives, including implementation of a revamped supplier pre-qualification process designed to foster competitive bidding and ensure maximum value for money.

Under the board's supervision, the management automated supplier registration processes, streamlining the onboarding of qualified suppliers while minimising potential risks. This ensured Procurement onboarded a pool of reliable and trusted vendors who can meet the stringent quality standards.

Further, KEMSA introduced lotting of tenders to facilitate multiple awards, encouraged competition and ensured that we brought on board a diverse pool of suppliers. The Authority also rolled out robust measures for Monitoring and Evaluation mechanisms, leveraging on technology to create end-to-end visibility.

HEALTHCARE DELIVERY

Technology

Recognising the power of technology in driving organisational efficiency, the leadership team invested in the acquisition and deployment of a new Enterprise Resource Planning (ERP) system. This was a critical component of our turn-around strategy. With technology it became easier to improve our operational efficiency through data-driven decision-making. The ERP system has helped us to improve supply chain management, optimise inventory levels and provide real-time insights into the status of KEMSA's operations. This investment underscores the Authority's commitment to leveraging technology for the betterment of healthcare delivery and it is already bearing fruit.



Essential Medicines

The Board also directed the management team to prioritise the procurement of vital supplies, tracer items and class-A products which are often urgently required and regularly used in all public health facilities. This, while serving the urgent needs of end users, also helped us to reduce the accumulation of dead and slow-moving stock and continually ensures that KEMSA remains on solid financial footing. We have also refurbished and strengthened our regional depots to better help us meet the health needs of Kenyans faster.



Resilience

As many will attest, the last one year has been a steep learning curve for KEMSA's Board, Management and Staff, as they sought to understand how an organisation can go through a major crisis, remain resilient and bounce back better. I acknowledge the diverse teams that have played their respective roles to ensure that together we keep fixing the problems facing our ship, thus ensuring that it remains afloat. Our ultimate goal is to steer it back to the operational excellence it was once known for and exceed the expectations of Kenyans and our various stakeholders, who we have been constantly engaging. It is important to mention that due to the collective effort, KEMSA has improved its Order Fill Rate from a low of 28 per cent to a high of 64 per cent in that one year, making us a more reliable health services partner.

Sustainability

To ensure that we remain sustainable, the leadership team embarked on robust recapitalisation efforts which eventually led the Cabinet to allocate KEMSA Sh2 billion. This was a significant step towards achieving financial stability for sustaining operations and fulfilling KEMSA's broad mandate, including our emergency response during the recent heavy rains.



The Future

Our transformation journey is only a year old. A great deal of work still awaits us. For instance, how do we eliminate dormant or slow moving stocks so that we can free up more resources and improve our cash flow? How do we forge new partnerships to improve our top, and bottom line? How can we continuously improve our governance and operational systems to become a more efficient organisation?

These are some of the challenges that we as the KEMSA team must keep addressing as we look forward to greater success in the next one year.



Right Stocking: KEMSA Uses Tech to Measure Demand and Ensure Supply

KEMSA has restructured its Demand and Supply Committee to guide the Authority on the right quantities of Health Products and Technologies to stock and supply based on customers' demand.

To avert excessive stock holding — which can lead to dormant and expired stocks — or understocking, which contributes to stockouts, KEMSA has rolled out demand planning to advise on appropriate inventory.

This customer-centric approach revolves around understanding, and anticipating, customer preference and behaviours by analysing historical sales data, market trends and customer feedback to inform the medical commodities list. KEMSA will also use predictive analytics from its

ERP, market research and demand data acquired through customers engagement to foster accurate demand forecasting. The renewed commitment on Demand and Supply is intended to bolster demand forecasting to enable KEMSA to make smarter supply decisions on inventory holding while meeting customer expectations.

In a move to institutionalise good business practice, KEMSA has been implementing reliable demand and supply planning processes that promote operational efficiency. These practices will enhance demand forecasts, optimise inventory management, improve customer satisfaction and adjust the supply chain based on demand patterns.

Effective demand and supply chain planning fosters collaboration between departments and the Ministry of Health.

Additionally, it mitigates risks associated with demand variability and provides objective information essential for budget and resource allocation. Consequently, all Intended procurements shall be subjected to relevant checks and scrutiny to determine if they are necessary and whether projected quantities will be fully absorbed by the counties and other clients.

Prior to initiating procurements, the Demand and Supply Committee, which draws members from various departments, will analyse requests vis-a-vis market trends before okaying procurement to proceed for tender or re-ordering. The Authority's Planning and Continuous Improvement team will then collate data from consumption trends to inform decision-making by the Demand and Supply Committee. Similarly, the Commercial Directorate shall continue to engage with customers and prospects to understand their needs and ultimately ensure satisfaction.

Demand planning in supply chain management is pivotal, acting as the compass that guides the entire operational ecosystem. It is the process that bridges the gap between a company's strategic goals and the execution of its operations. Demand planning revolves around comprehending, predicting and meeting customer requirements while optimising inventory levels, production capacities and resources. This is a job that KEMSA is striving to get right.

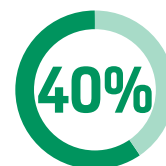

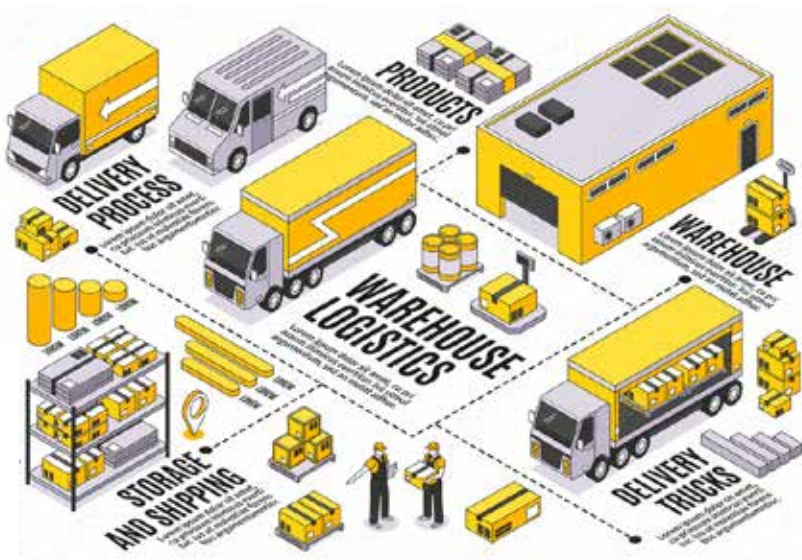
delivery nationwide. With its strategic location, advanced infrastructure, and commitment to excellence, the facility is poised to set new standards for service accessibility and efficiency in the region.

KEMSA board led by its Chair Irungu Nyakera, expressed eagerness to unlock the true potential of the eBoard Investment and using its power to digitize their processes. "This platform will be implemented immediately in the upcoming board and committee meetings, to track all agendas on real time basis. We expect the secretariat to upload all information to enable us make quick references for all meetings," the chair stated. Nyakera called on the consultant to

provide continuous support to ensure that the structure remains intact so that it can assist all future boards.

The CEO committed to use the platforms in all future meetings, noting that it will be useful in assisting management to cascade and track their progress to board level with much ease.

Validation Process and Key Milestones:

The TPV assessed key milestones such as Governance and Oversight, Optimization of Distribution Management, Procurement, Management Control Implementation, Supplier Vendor Management, GDP Compliance Audits, and Recommendation Implementation. Procurement Excellence:

The validation recognized KEMSA's procurement efforts, scoring 93.5%. Scoring 97%, KEMSA's governance structure was lauded for having all relevant board guiding documents in place and in use. This score reflects KEMSA's commitment to transparency and effective leadership.

Management Control and Supplier Vendor Management:

While these areas scored 85% and 83% respectively, the assessors noted room for improvement. The report recommended enhancements in these areas to further strengthen KEMSA's operational efficiency and supplier relationships.

Recommendations Implementation:

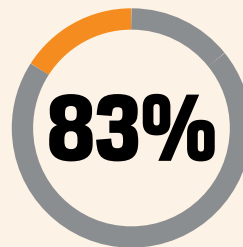

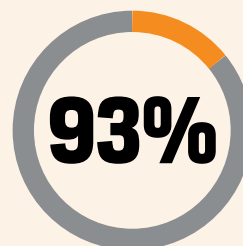

KEMSA Partners with UNFPA to Boost Family Planning

The Authority is advancing reproductive health services by enabling distribution of 450,000 self-injectable contraceptives doses as part of a campaign to reduce unplanned pregnancies and reduce maternal deaths



KEMSA's efforts to strengthen its Supply Chain Services are bearing fruits!

This is evidenced by the new contract that the Authority recently signed with the United Nations Population Fund (UNFPA) to distribute 450,000 doses of contraceptives worth Sh57 million (\$348,000).

Known scientifically as Subcutaneous Depot Medroxyprogesterone Acetate (DMPA-SC), the contraceptives are expected to enhance access to reproductive health services across the country. The medicines were procured by UNFPA with funding from the UK government.

KEMSA's role is to ensure they are distributed to health facilities in every part of Kenya. The contraceptive is a user-friendly injectable that can be administered by trained individuals, including community health workers, or by the users themselves. About 60,000 doses have already been delivered to various hospitals in the Authority's quest to meet UNFPA's and the Ministry of Health goals to boost access to family planning beyond traditional healthcare settings.

Mr Anders Thomsen, the UNFPA Kenya Representative, said the supplies will help prevent unintended pregnancies

as well as maternal deaths. "Funding for the family planning programme is a vital component of the support we receive from the UK government," he said. "It ensures that women can access and choose from a range of quality family planning methods, no matter where they live in the country. This in many ways, helps us deliver on the commitment to end preventable maternal deaths."

The Acting Director General in the Ministry of Health, Dr. Patrick Amoth, said the Government was committed to ensuring easy access of family planning supplies to women of reproductive age as the

country steps up efforts to achieve 64 per cent of contraceptives uptake by 2030.

"Kenya has made significant progress in promoting access to family planning, with the modern contraceptive prevalence rate rising to 57 per cent in 2022, up from 53 per cent in 2014," said of the progress the ministry has made in achieving its family planning medicines uptake goal. "We are expanding access to family planning beyond traditional healthcare settings".

Despite misinformation on various family planning methods and high financial cost of access, she said, the Health ministry has been creating awareness about the need for women of reproductive age to use contraceptives.

Among others, the contraceptives set to benefit over 400,000 women are also expected to prevent 42,750 cases of unintended pregnancies and 122 maternal deaths.

The Deputy Development Director at the British High Commission, Ms Eduarda Mendonca-Gray said sexual and reproductive health and rights are key priorities for the UK government.

"Since 2010, we have been supporting family planning efforts in Kenya and we remain committed to working collaboratively. We will continue working with the Health Ministry to empower women to plan for their lives and future, and to decide when to have children by choice, not by chance," she said.

According to the 2022 Kenya Demographic Health Survey, 66 per cent of currently married women and 89 per cent of sexually active, unmarried women need family planning services and medicines.

Kenya has made significant progress in promoting access to family planning, with the modern contraceptive prevalence rate rising to 57 per cent two years ago, up from 53 per cent ten years ago.



During the same period, the unmet need for family planning was reduced from 18 to 14 per cent.

Despite this progress, barriers such as the high financial cost of access and uncertainty over supply still hinder efforts to meet the demand for family planning services.

The contraceptive is a user-friendly injectable that can be administered by trained individuals, including community health workers, or by the users themselves. About 60,000 doses have already been delivered to various hospitals in the Authority's quest to meet UNFPA's and the Ministry of Health goals to boost access to family planning beyond traditional healthcare settings.



Fighting Malaria, One Net at A Time

KEMSA has in the last five months overcome great odds, especially floods, to reach millions of Kenyans who need treated nets to keep killer mosquitoes at bay

More than five million mosquito nets have been distributed in ten counties across Kenya as part of a drive to combat malaria, which kills more than 10,000 people each year.

KEMSA delivered 5,404,018 long-lasting insecticidal-treated nets, whose distribution has been sponsored by the Global Fund. The Fund has partnered with KEMSA and the Ministry of Health to supply nets to 18 targeted counties. The successes recorded so far are a testament of KEMSA's distribution dexterity and commitment to ensuring that medical supplies are available in remote and hard-to-reach areas of Kenya.

From mid-January, the Authority embarked on last mile distribution to reach families in Kisumu, Siaya, Kisii, Nyamira and Migori counties in the Nyanza region and Kwale, Mombasa, Lamu, Taita Taveta and Tana River counties at the Coast. The distribution is part of ongoing efforts by the Ministry of Health and Global Fund to provide an effective mass protection against malaria.

Distribution was carried out in areas hardest hit by the recent floods, with the main target being villages that had been cut off by collapsed bridges or where roads had been submerged by floods or rivers that had burst their banks.

Despite facing numerous challenges, the Authority has devised logistical solutions to ensure that supplies reach the mapped sites on time so as to protect vulnerable citizens from the adverse impact of contracting malaria. Other malaria-prone counties set to benefit from this

campaign include Kilifi, Busia, West Pokot and Trans Nzoia. Consignments have already been dropped off and are only awaiting distribution to the targeted households. Another consignment meant for Narok is already at KEMSA stores awaiting delivery to the area.

KEMSA is expected to deliver a total of 10,915,002 nets to various households in regions classified as malaria endemic areas as a form of personal protection. It is also awaiting delivery of 792,755 nets from Arusha, Tanzania which will be distributed in Turkana and Baringo counties in the Rift Valley and Kirinyaga County in central Kenya.

The mass nets distribution drive kicked off with household registration by teams from the Government's Malaria Programme. Information about the beneficiaries was then uploaded on Digimal, an electronic platform used to track beneficiaries' data. Digitisation of the process has prevented leakage and loss of the nets.

According to the latest Kenya malaria indicator survey report, about four million Kenyans contract malaria annually, with more than 10,000 dying from the disease.

According to various health survey reports, malaria is among the leading killer diseases in the country. The most affected demographics are expectant mothers, children aged five years and below and the elderly.

Studies have shown that use of nets can reduce malaria infections, severe disease and death.

STRENGTHENING DISTRIBUTION

Drive Towards Integrated Distribution Planning

The proposed integrated distribution system aims to enhance medicines availability at health facilities through timely order processing and distribution. By consolidating and integrating program orders, the system also seeks to achieve distribution cost efficiency and reduce the number of distribution trips per quarter, ultimately leading to more funds being allocated to buying medicines.

Key Outcomes and Recommendations:

A major outcome of the workshop was the consensus on establishing a National Technical Committee to oversee and



coordinate the ordering of program commodities. This committee would work towards developing a national medicines dashboard to enhance supply chain visibility and a common Logistic Management Information System (LMIS) for medicines ordering and approval, linked to the Kenya Health Information System (KHIS).

Anticipated Impact:

The successful implementation of integrated distribution planning is expected to revolutionize healthcare distribution in Kenya. It will increase KEMSA's operational efficiency and cost-effectiveness, improve service delivery at health facilities, and enhance customer satisfaction. With a

more streamlined and efficient distribution system, more patients will receive timely treatment, leading to improved overall health outcomes.

The Integrated Distribution Planning Workshop marks a bold step towards transforming Kenya's healthcare distribution system. The proposed integrated distribution system has the potential to address long-standing challenges and improve access to essential medicines. As stakeholders work towards approvals and implementation, the future of healthcare distribution in Kenya looks promising, with the potential to significantly impact the lives of millions.

Integrated Distribution Planning Workshop



KEMSA through the Medical Commodities Program with support from Africa Resource Centre held a formative workshop on integrated distribution planning between 22nd - 25th April 2024. The workshop brought together MoH strategic programs technical leads, Counties, USAID, USAID implementing partners, Amref and KEMSA teams. Participants drew insights from their different levels of expertise on the best possible approach to attaining a synchronized and integrated downstream supply chain for all program Health Products and Technologies (HPT's).

The need for harmonized ordering timelines across all strategic programs was evident as key to realizing an integrated distribution system.

With reduced operational costs, more funds will be allocated to buying medi-

cines equating to more patients receiving treatment and improving overall health outcomes. The meeting had a consensus on the need to have one National Technical Committee to oversight and coordinate the ordering of program medicines, a nation medicines dashboard to enhance supply chain visibility and a common Logistic Management information system (LMIS) for medicines ordering and approval which should be linked to the Kenya Health Information System (KHIS).

The integrated distribution planning concept is yet to undergo approvals by the different levels of governance within the health sector. Upon complete approval, its successful implementation will not only increase KEMSA's operations efficiency and cost effectiveness but, will also improve service delivery at health facilities and improve customer satisfaction.

The KEMSA programs HPTs integrated distribution system targets to:

- Enhance medicines availability at health facilities through timely order processing and distribution.
- Achieve distribution cost efficiency by consolidating and integrating program orders for optimal distribution vehicle utilization and economies of scale.
- Reduce distribution costs by optimizing the number of distribution trips to a county per quarter.

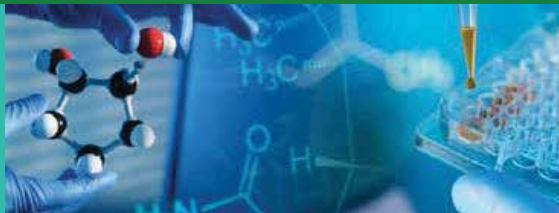
