**NOTE:**

1. Successful bidder(s) will be offered a two (2) year framework contract renewable automatically after the first year if not terminated due to non-performance or market dynamics.
2. The quantities indicated above are initial requirements. Subsequent additional quantities will be called-off 'as and when' need arises.
3. Prices shall remain fixed over the contract period.
4. Tenderers will be allowed to tender for both lots per item. However, a tenderer can only be awarded one lot per item.
5. Bidders should provide one sample to represent both lots per item. Bidders who submit two different samples for any given item will have their samples disqualified.
6. Firms that share directors will not be awarded both lots for an item.
7. No single manufacturer can be awarded both lots for an item.
8. Bidders shall be required to provide CR12 showing shareholding and nationality of shareholders issued by the Registrar of companies. CR 12 should have been issued within the last 12 months.
9. The award ratio shall be 60:40 where the lowest bid for each lot shall be awarded the 60% ratio and the second lowest bid shall be awarded the 40% ratio as per quantities detailed above.
