The following query was raised by an interested bidder and we hereby respond as follows:

Question 1:

Following our registration submission on Supply of Tender No. KEMSA/ONT02/2021-2023 for supply of health products(Tropical, Disinfectants, Antiseptics and oral liquids, we kindly request for all specifications of Hand Sanitizer (Tropical) which we intend to submit our bid because what is given on page 43/137 are just evaluation parameters and not specifications of the same.

Answer:

Product Specifications: Alcohol rub/Hand sanitizer Solution 500ml

Product parameters includes;

Should contain at least minimum of 70% Isopropyl alcohol.

The solution should be rinse type, non-sticky, unscented with a moisturiser.

Packaging parameters:

Should be contained in a compatible container of volume 500ml.

Self-standing bottle, equipped with pump that requires activation before initial use.

Container should allow visibility of the liquid.

Must have a proper dosing system that is capable of delivering between 0.03ml and 0.5ml per squeeze.

Labelling parameters:

Labelling on primary packaging must include:

- Manufacturers name and address.
- Country of origin.
- Composition and amount.
- Batch No, Date of manufacture and Expiry.
- Manufacturer's product reference.
- Type of product and main characteristics.

- Information for particular storage conditions (temperature, pressure, light, humidity, etc.), as appropriate (or equivalent harmonised symbol)
- Information for handling, if applicable (or equivalent harmonized symbol), warning information (for external use only).
- Instructions for use.
- Should conform to KEBS / ISO standard or equivalent.
- Manufacturer must be KEBS / ISO certified or equivalent.
- Certificate of analysis for the batch submitted as tender sample. The certificate must contain among other parameters, identification, assay, specific antimicrobial activity (antimicrobial challenge test) against S.aures, P. aeruginosa, C.albicans and A. brasiliensis.

Labelling on the secondary and other packaging unit: Labelling to be the same as primary packaging.

Extra information required, Number of units and weight per box as per tender document.

All labelling should be in English
