In accordance with ITT Clause 7.1 (Clarification of Tendering Document) of the Open International Tender (OIT) issued under the above reference, we hereby respond to queries raised by a prospective bidder:

Question 1:

On sample submission, is a bidder also required to submit samples for all the items in lot 3 such as samples of computers, ups and printers?

Response: Bidders are required to submit a manufacture's brochure as per the tender document.

Question 2:

On Instrument integration hardware quantities, I see more than two different gadgets in the requirements, my question is, is a bidder required to bid for all the items in the specifications or just one?

Response: Bidders are required to bid for all the items.

Question 3:

LOT 1 - NETWORK CABLING

There are 18K BTU Air Conditioners to be installed. Are suppliers expected to quote for the Air conditioners as well, since in the document, there is no supplying of these.

Response: Yes, bidders are required to quote for the air conditioners as well.

Question 4:

Dear Sir /Madam Our team went to conduct a site survey as requested on the bid document no KEMSA/PROC/ADM/06/22/41 on 10/2/2022 but they were not able to access the facility since the Hospital administration advised them that they were not part of that project and that they will write a letter to Kemsas to request their removal from the list citing they have the system already in place.

We were kindly seeking for clarification on how to go about this since it was a mandatory requirement to have the site survey form signed.

Question 5:

On page 27 ON SCHEDULE FOR REQUIREMENTS, item number 7, the quantity of desktops plus ups is indicated as 18, however on page 30, on SCHEDULE FOR GOODS LOT NO 3, The same item now listed as item number 1, the quantity of desktop plus ups is indicated as 144. Kindly provide clarifications as to whether one is required to tender for:

- a) 18 desktops and 18 ups
- or
- b) 144 desktops and 144 ups
- or
- c) 72 desktops and 72 ups.

Response:

The requirement is 144 desktops and 144 UPS

Question 6:

Kindly clarify the exact size labels of (30 rolls of 1000 labels ,white , 2 labels per row, 1inch wide) for the Barcode Printer. Is it 4x1 inch, 2x1inch and etc.

Response:

Height: 0.5 inch to 1.5 inch

In view of the above, you are advised to submit the "SUBSTITUTION," or "MODIFICATION;" of your tender document in the tender box on or before the tender closing date.

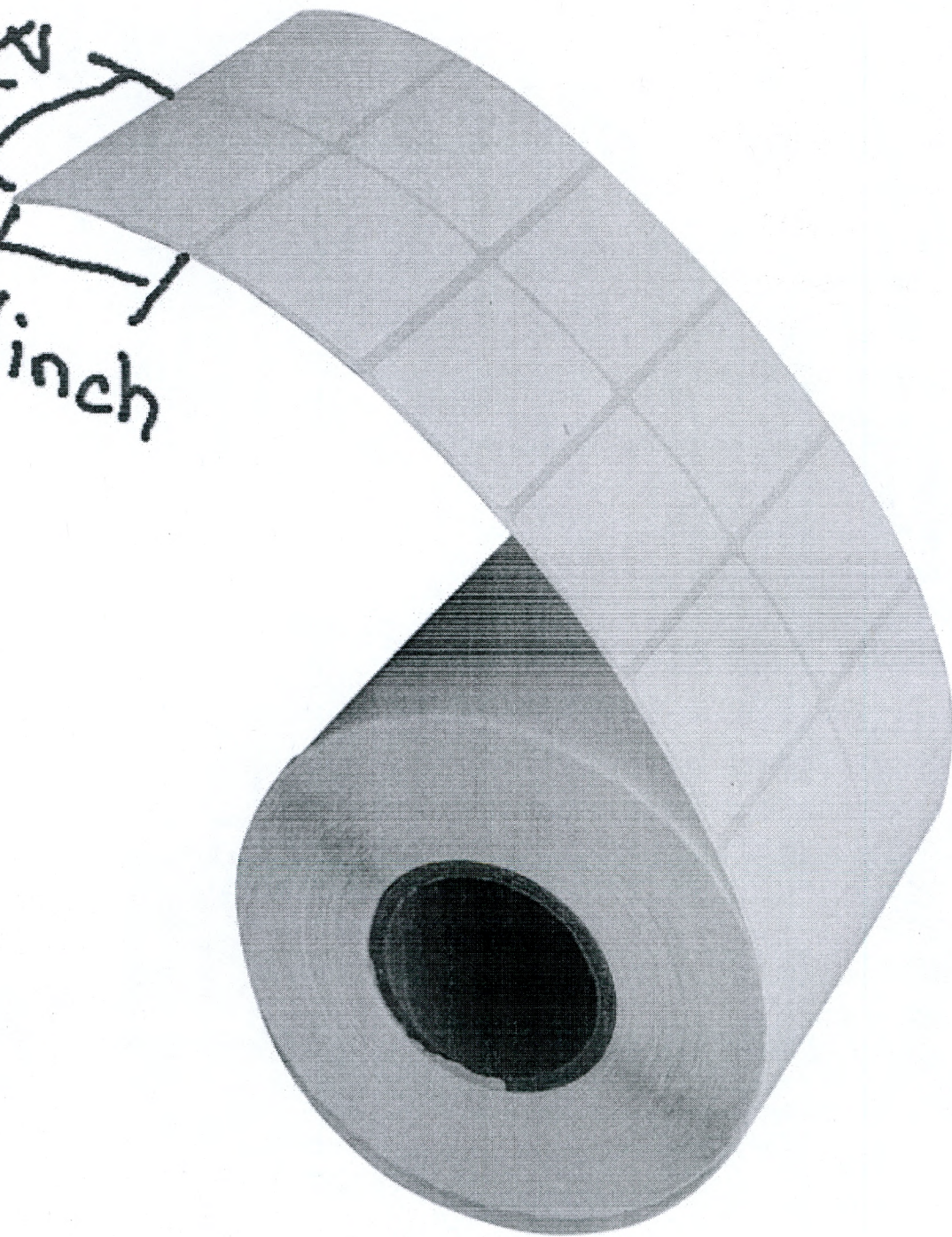
