Bidders in attendance were taken through the mandatory Preliminary and Technical requirements of bid submission and there after a walk to the new warehouse the Inrack firefighting equipment and lifts installation areas.

NCA is a mandatory requirement for any local contractor as they are recognized and registered under the body and therefore the certificate should be attached In the event of a JV, then the local company NCA certificate shall be attached. Foreign companies are also only eligible to bid for projects solely with a value limit of category NCA 1 as stipulated in the act.
