The following queries were raised by interested bidders and we hereby respond as follows:

Question 1:

Kindly send us the technical specifications for Item No.1-PD01DET005- Enzymatic Detergent.

Response:
Enzymatic Detergent specifications

- Pack size: 4 Litres
- Formulation of protease, amylase, lipase, carbohydrates and proprietary enzymes with A.P.A (Advanced proteolytic Action) which removes all bioburden.
- Must inhibit rust
- Must be a multi-tiered enzymatic detergent designed for both manual cleaning and compatible with ultrasonic washers.
- Must be safe for use on all instruments and scopes, and should not harm any metals, plastics, rubber or corrugated tubing.
- Must be non-foaming.
- Must be of minimal dilution rate (at least 4ml or less per litre of water)

Question 2:

Item No. 2 - Oxagal Disinfectant - Please confirm the contents of the product.

Response:
Oxagal Disinfectant specifications

Active ingredients: Peracetic acid/ Acetic acid/hydrogen peroxide as 0.5/6/10% respectively.

Others: Demineralized water and filtered to 0.2μ

A handwritten signature in blue ink, appearing to be 'M. N.', is written over a horizontal line.

Physical properties: Colorless, water soluble liquid, density of approximately 1.04 and pH of 2 ± 0.2 .

Tolerance: Must be compatible with disinfection components, dialysis appliances and surfaces.

Pack size: 5L

N/B Provide certificate of conformity/analysis and data sheet.

Question 3:

Item No. 3 - Formaldehyde 40% Solution, must it be registered with both KEBS and the Pharmacy and Poisons board?

Response:

Only Pharmacy and Poisons board (PPB) listing is required. Not both PPB and KEBS.
