- Must have underwritten GPA/WIBA premium of more than 800m: Is this for both brokers and Underwriters or underwriters only?

- The requirement of paid up capital of Kes. 600million is applicable to Underwriters whereas for brokers, they must have a paid up capital of Kes. 25 million
- The authority's requirement is that both Underwriters and Brokers Must have met the requirement of GPA/WIBA premium of more than 800m
